RSCDS Wellington Region Treasurer's Report for AGM, 7th November 2023

Charitable Status:

In accordance with reporting requirements we need to note the objectives of our organisation comply with a charitable not-for-profit status.

The Wellington Region of the New Zealand Branch of the Royal Scottish Country Dance Society is a not-for-profit organisation that exists to promote and support the enjoyment of Scottish Country dancing within Wellington and to work with other regions and the New Zealand Branch to support dancing across New Zealand, in collaboration with the international organisation.

The Wellington Region coordinates the Regional dancing calendar comprising many club activities, and organises a series of region dancing workshops (the Region classes), a New Dancers' Celebration dance and other special dance events. The Region also supports youth dancing, and the availability and development of dancing tutors and musicians. Activities are promoted by emails to clubs, a website and by a regular newsletter - *Harbour City Happenings*.

The Wellington Region does not charge membership fees. The costs of its activities are funded by a modest surplus generated from the running of events, in particular the Region classes. All funds received are used to support the objectives of the Royal Scottish Country Dance Society in the Wellington Region.

Financial Statements:

I present the accounts for the financial year ending 31 August 2023 . These accounts have been reviewed by Patrick Waite QSM FCA.

I would like to note the ongoing support to the Region provided by the kind services of Pat. We are very fortunate to have someone with his level of knowledge and experience available to call upon, and I would like to take this occasion to thank him on behalf of the Region.

Income from events run by the Region includes:

- 2022 New Dancers Celebration at Knox Church Hall \$1,211.17 made a net profit \$477.17
- RSCDS 100 Anniversary Afternoon of Early Wellington Dances \$483 made a net profit of \$181.19 (catering costs \$96 paid Sept 2023/24)
- Donations collected at Summer dancing evenings totalled \$125.30 with expenses of \$20 for a surplus of \$105.30.

• Region classes (calendar 2022-23) made a net profit of \$401.99, detailed below:

As the costs and receipts for the calendar 2022 classes are split over two financial years, the net surplus for classes for the *financial* year 2023 is \$401.99. Receipts for Advanced Technique classes (Sept 22) received after 31 August 2022, and recognition of expenses for the Basics 2, Advanced Technique (Sept 22) which combined to contribute an additional net deficit of \$276.75.

Note: The intermediate classes attendance was lower and expenses higher as there were 4 x 2 hour evening classes with 2 musicians per session rather than 2 x 3 hr afternoon sessions resulting in a deficit of \$55.

In addition:

- 60th Anniversary book income \$263
- our funds in the bank earned interest of \$97.22 (less than 2021/22 as no interest from Term deposit)

The main outgoings for the year other than for classes included:

- Payments were made to Region Officers for the 2021-22 year of \$600.
- The Region reimbursed Regional Clubs Advertising a total of \$600 to help encourage New Dancers. The Tawa, Lower Hutt and Johnsonville clubs each received \$200 reimbursement in 2022/23.
- Website costs (included under Advertising) totalled \$193.59
- The Region Committee provides the Harbor City Happens to all dancers in the Region for free, a small fee is still payable for those who choose to receive a paper copy. It ran at a loss of \$45.60.

Rent payments were made for committee meetings (Petone Community House, \$86) and AGM (St Johns, \$60).

The combined income from activities and expenditure resulted in the reported net position for the year being an overall deficit of \$941.34. This is reflected in our overall bank balances of \$20,544.55.

However allowance needs to be made for:

- RSCDS fees received and banked in August 2023 payable for the 2023-24 year \$2,984 and amounts paid in 2023 that were received in 2022 (\$4,100)
- Receipts received for Region Classes held in September 2022 \$248.

• Payments made in 2022/23 relating to prior periods \$148 and payments due in 2022/23 not yet made \$716

After taking these amounts into account, the position would reflect a deficit of (\$145.34) for the year.

Westpac Term Deposit

The term deposit of \$9,252.16, being our reserve for unexpected contingencies, remains invested at a rate of 2.5% and will mature on 11 December 2023. This will be automatically reinvested for a further 2 years. No income from this investment is recognised in these accounts as the interest will be compounded on maturity and reinvested.

Bank Accounts:

The Region now operates two General accounts and two Youth accounts – one each for day-to-day use, and one for 'savings'. Both savings accounts earn a small amount of interest. A third General account receives receipts and pays expenses for the Harbour City Happenings.

Thank you for the Committee's support during my first year as Treasurer. I would like to thank the current executive team particularly Michele Miller for her assistance.

Thanks also to all the committee members for their efforts and dedication to dancing in Wellington.

I have reviewed the accompanying financial statements of the Royal Scottish Country Dancing Society Incorporated, New Zealand Branch – Wellington Region for the year ended 31st August 2023.

A Review is limited primarily to enquiries of association personnel and analytical review procedures applied to financial data and thus provide less assurance than an audit. I have not performed an audit and accordingly I do not express an audit opinion.

As with other organizations of a similar nature, control over income before it is recorded is limited, and no practical review procedures exist to determine the effect of this limited control.
